Registration fees:

Fundraising/Sponsorship:

You aim to raise/set a target of £100 per person if you can. We understand raising sponsorship is not always easy and will support you the best we can. We reserve the right to remove your place if you have not demonstrated your intention and plan to reach your target. We cannot refund donations in the event of cancellation or if you are unable to take part.

Age limits:
